

## **Seven2 Agrees to Acquire HRK LUNIS, a Leading German Independent Wealth Management Platform, from J.C. Flowers**

Munich, March 28, 2025 – Seven2, a leading European private equity firm, announced today the signing of a binding agreement with J.C. Flowers & Co., a private investment firm dedicated to investing in the financial services industry, to acquire a majority stake in HRK LUNIS, a prominent German independent wealth management platform. This acquisition marks Seven2's first investment in Germany and a strategic step in its European expansion. The transaction, which remains subject to applicable regulatory approvals, is expected to close in Q4 2025. Terms of the transaction were not disclosed.

The HRK LUNIS management team will continue to lead the company going forward, including HRK LUNIS CEO and co-founder Andreas Brandt who will also retain a significant ownership stake as part of the transaction.

Andreas Brandt and J.C. Flowers built HRK LUNIS with the vision to provide clients across Germany with an independent, comprehensive wealth management offering featuring innovative products and superior service.

Today, HRK LUNIS is among the top five largest German independent wealth managers with over 100 employees managing more than €6.6bn AuM/AuA for more than 2,200 clients, and operating offices across eight cities.
